Licences are typically issued for either a one (1) year or five (5) year period and expire on the anniversary of their issuance. Licencees may reapply to the Ontario Farm Products Marketing Commission (Commission) for a licence six months prior to that time.

Note that the Commission may, after a hearing, suspend or revoke or refuse to renew a licence for failure to observe, perform or carry out the *Farm Products Marketing Act*, the regulations, the plan or any order of the Commission or of the relevant marketing board. In addition, processing the commodities above without a licence from the Commission is in contravention of the *Farm Products Marketing Act* and regulations.
